In a format of "AM all breeds show" and "PM Group shows" giving a fast turnaround for exhibitors to get home in a safe timeframe. This gives the Clubs more flexibility in dealing with enduring General Specials which, at the end of the day, is time consuming. The Regional members believe this a win/win situation for Regional members and DOGS NSW for the following reasons:-

- DOGS NSW will not lose any levies per Group show, as the DOGS NSW levies are per dog.
- Clubs will reduce overheads, ie, no General Specials sashes required.
- Exhibitors will be enticed to win a Group specially "Best In Show."
- Exhibitors leave at a reasonable hour to travel home (OH&S).
