**AUSTRALIAN NATIONAL KENNEL COUNCIL LIMITED
REGULATIONS PERTAINING TO NON RESIDENT JUDGES**

1. General Regulations– All Judges (Amended 10/24, 7.5.13 – effective 01/01/25)

- 1.1 A Non Resident Judge must be able to verbally communicate with exhibitors to a degree that their directions and decisions are clearly understood or have a competent interpreter.
- 1.2 If a Non-Resident Judge is unable to read English, the Affiliate or Organisation conducting the event is to provide an assurance that all ANKC Ltd Rules, Regulations, Policies, Procedures and breed standards have either been translated in writing into a language understood by the Non-Resident Judge or communicated orally. The assurance, signed by both the Affiliate or Organisation and the judge, must accompany the application.
- 1.3 The Affiliate conducting the show must have some knowledge of the Non Resident Judge and their background and ability to judge.

2. Regulations – Conformation Judges (Amended 10/24, 7.5.13 – effective 01/01/25)

- 2.1 Unless forbidden by the Regulations of their Country of residence, for a Non-Resident Judge to be approved to judge Group Specials in Australia, but not the individual breeds for which they are not approved at breed level, they must be approved and have awarded in their Country of Residence Challenge Certificates or their equivalent, to a minimum of 70% of the Major breeds* in each group as per the ANKC Ltd recognised Group/Breed list.

***Major breed** a breed that has an average of 60 plus registrations over the last 3 years as recorded on the Dogs Australia Website.

- 2.1.1 Best in Show at Championship or CACIB Shows can only be judged by judges who are approved to judge Best in Show in their Country of Residence, provided that judge is approved by ANKC Ltd to judge at least 4 Group Specials in Australia.

Alternatively, should a judge from a non FCI Country be able to judge 70% of the Breeds in each of the 7 Groups as per the ANKC Ltd recognized Group/Breed list, the ANKC Ltd may then grant permission for that judge to judge Best in Show. FCI Judges Regulation 2 e prevents this alternative being applied to FCI Judges.

- 2.2 Notwithstanding the provisions in 2.1 the following Regulations are currently applied by individual National Canine Organisations.

Fédération Cynologique Internationale (FCI) (Amended 06/25, 5.5 – effective 01/07/25)

In accordance with FCI Show Regulations 2 e, judges from FCI National Canine Organisations may under no circumstances agree to judge a breed at any show for which they are not approved by their own NCO (National Canine Organization) and for which they are not listed in the FCI Judges Directory. The same applies for judging at Best in Group and Best in Show level.

When seeking approval to judge at an FCI International Show in Australia, a Non-Resident Judge may only apply to award the CACIB to breeds for which they are individually listed in the FCI Judges Directory, failing to comply with this requirement will result in the FCI invalidating the confirmation of the CACIBs incorrectly awarded.

FCI Judges judging at a Non-FCI Championship Show in Australia may only complete an ANKC Ltd Judging Declaration for Additional breeds form for breeds not recognised and/or registered by their NCO.

The ANKC Ltd Judging Declaration for Additional breeds form may be competed for the following breeds which are not included in the FCI Group Listing but are included in the Dogs Australian Group Listing.

- Australasian Bosdog, Murray River Retriever and Tenterfield Terrier
Bluetick Coonhound and the American Hairless Terrier and Biewer Terrier.

The ANKC Ltd Judging Declaration for Additional breeds form must be submitted with the Overseas Judges Application Form.

The ANKC Ltd Judging Declaration for Additional breeds form will be available on the Dogs Australia website. [This declaration form is included in the Judge's Contract.]

Canadian Kennel Club (CKC) (Amended 06/25, 5.5 – effective 01/07/25)

At FCI International CACIB Shows CKC judges are only allowed to judge and award CACIB's to the breeds that they are approved to judge at Championship Shows in Canada.

CKC Licensed judges are permitted to judge at Championship Shows in foreign countries and issue Challenge Certificates only for breeds that they are licenced for in Canada.

An ANKC Ltd Judging Declaration for Additional breeds form may be completed for breeds listed in Appendix A to these regulations, if the Overseas Judge is required by the Affiliate Club to judge that breed/s at their Championship Show.

For any breed other than the breeds mentioned in Appendix A, the judge must include with their Overseas Judges Application Form, a ANKC Ltd Judging Declaration for Additional breeds form for the specific CKC registered breed/s the Affiliate Club has requested they judge but they are not currently licensed by the CKC to judge.

Note: The judges qualifications will be based on the information contained in the Judges listing on the CKC website unless written correspondence is received from the CKC stating otherwise.

The ANKC Ltd Judging Declaration for Additional breeds form will be available on the Dogs Australia website. [This declaration form is included in the Judge's Contract.]

The Royal Kennel Club (UK) (Amended 06/25, 5.5 – effective 01/07/25)

At FCI International CACIB Shows RKC judges are only allowed to judge and award CACIB's to the breeds that are recognised by the FCI on a definitive basis and that they are approved to judge and award Challenges to at Championship Shows in the United Kingdom.

Where an applicant is approved by the Royal Kennel Club (RKC), to judge a group or Groups at Championship Show level, and has Open Show experience or has issued Challenge Certificates outside England, subject to compliance with 2.1, may be approved to judge at Group level in Australia for those groups/breeds so qualified, subject to the Non-Resident Judge providing the details required, listed as follows:

- (a) Date of Open / FCI / Green Star Shows
- (b) Name of Show
- (c) List of Breed/s judged
- (d) Number of Dogs judged in each Breed
- (e) List of "any other variety" breeds judged together with the number of dogs in each breed judged.

The above information is to be provided with the initial application for approval.

ANKC Ltd Judging Declaration for Additional breeds form may be completed for breeds listed in Appendix B to these regulations, if the Overseas Judge is required by the Affiliate Club to judge that breed/s at their Championship Show.

For any breed other than the breeds mentioned in Appendix B, the judge must include with their Overseas Judges Application Form, a ANKC Ltd Judging Declaration for Additional breeds form for the specific RKC registered breed/s the Affiliate Club has requested they judge but they are not currently licensed by the RKC to judge.

Note: The judges qualifications will be based on the information contained in the Judges listing on the RKC website unless written correspondence is received from the RKC stating otherwise.

The ANKC Ltd Judging Declaration for Additional breeds form will be available on the Dogs Australia website. [This declaration form is included in the Judge's Contract.]

American Kennel Club (AKC) (Amended 06/25, 5.5 – effective 01/07/25)

At FCI International shows, AKC judges are eligible to judge and award the CACIB provided that the following conditions are fulfilled:

1. The breeds they are scheduled to judge are recognized by the AKC (this does not include Miscellaneous and FSS.
2. They are allowed, under AKC regulations, to judge the breeds in question at AKC events and award them championship points.

AKC Licensed judges are permitted to judge at Championship Shows in overseas countries and issue Challenge Certificates only for breeds that they are licenced for in the USA.

An ANKC Ltd Judging Declaration for Additional breeds form may be completed for Miscellaneous and FSS (Foundation Stock Service Breeds) and breeds that are not recognised by the AKC, listed in Appendix C to these Regulations, if the Overseas Judge is required by the Affiliate Club to judge that breed/s at their Championship Show.

For any breed other than the breeds mentioned in Appendix C. the judge must include with their Overseas Judges Application Form, the ANKC Ltd Judging Declaration for Additional breeds form for the specific AKC registered breed/s the Affiliate Club has requested they judge but they are not currently licensed by the AKC to judge.

Note: The judges qualifications will be based on the information contained in the Judges listing on the AKC website unless written correspondence is received from the AKC stating otherwise.

The ANKC Ltd Judging Declaration for Additional breeds will be available on the Dogs Australia website. [This declaration form is included in the Judge's Contract.]

- 2.3 Where an application has been received from a Non Resident Judge who has previously been approved by their Country of Residence's Controlling Body to award Challenge Certificates, or their equivalent, in their Country of Residence, and are currently on an "inactive" list due to being employed by their Controlling Body, and their Country's Rules and Regulations prevent them from judging in their Country of Residence, they may be approved to judge in Australia, subject to:
 - 2.3.1 The person has awarded Challenge Certificates, or their equivalent, in their Country of Residence within the previous ten [10] years, and;
 - 2.3.2 The person has judged the breeds they are seeking approval for within the last three [3] years at a recognised show conducted under the auspice of a recognised Controlling Body.
- 2.4 Judges who have moved their country of residence and are not approved to judge some or all the breeds in their new country of residence that they were approved to judge in their original country of residence, will be eligible to be approved by the ANKC Ltd to judge the breeds they were approved to judge in their original country of residence.

Judges, who have been licenced by a neighbouring Country which is not their Country of Residence, shall be allowed to Judge on furnishing documentation from their Country of Residence and their Country of Licence. **(05/05)**
- 2.5 A Non Resident Judge approved on a provisional permit or apprentice basis is not eligible for approval to Judge at Championship Shows in Australia for those breeds or Groups subject to such provisional permit or apprenticeship.

3. Regulations - Judges Application

3.1. The Applicant Judge must complete –

- 3.1.1. An ANKC Ltd Non Resident Judges' Application form;
- 3.1.2. An ANKC Ltd Judge's contract;
- 3.1.3. Provide a statement of authorisation of judging qualifications from their controlling body (if not provided, ANKC Ltd will obtain, at extra charge);
- 3.1.4. Conformation Judge - a completed copy of the current ANKC Ltd recognised group Listing must accompany the application form (addendum A);
- 3.1.5. Performance Judge
 - 3.1.5.1. A completed listing of the events and classes the Judge is licensed for must accompany the application form (addendum B);
 - 3.1.5.2. The judge must agree to provide courses/test details within the required timeframe.

4. Regulations - Application Submission

- 4.1. The Affiliate seeking approval for the judge must submit a completed Overseas Judges Application form, with relevant Addendum A and/or B, to their ANKC Ltd Member Body at least 9 months prior to the date of the Event. Where than more than one Event is to be judged, the submission must be 9 months prior to the first event.
- 4.2. If the judge is being subcontracted to other affiliates, details of all assignments must be included in the application, with copies of sub-contract form(s) for the additional assignments attached.
- 4.3. The Member Body submits the application to the ANKC Ltd Administrator.
- 4.4. Applications received less than nine (9) months prior to the date of the first Event may only be approved by the ANKC Ltd Non Resident Judges Approval Board if **extenuating** circumstances are provided. (10/99)
- 4.5. The ANKC Ltd Administrator is empowered to grant approval for late submissions, without approval of the Non Resident Judges Approval Board , provided that:
 - the late submission fee has been paid
 - the application is not received within 3 months or less of the Event date
 - there is no doubt of the eligibility of the Judge concerned to officiate. (05/00)
- 4.6. However, Regulations 4.1 and 4.2 shall not apply where a previously approved Non Resident Judge is unable to fulfil a judging appointment. In these circumstances a qualified substitute Non Resident Judge may be approved by the ANKC Ltd. The application for approval of a substitute Non Resident Judge must be accompanied by all related correspondence concerning the reasons for the previously approved Non Resident Judge's inability to fulfil their agreed judging appointment/s. Where an Non Resident Judge is unable to fulfil an appointment the clearance for that judge will remain for no longer than 24months. After that time another clearance will have to be applied for. **(05/05)**
- 4.7. The ANKC Ltd reserves the right to withdraw its approval of any Non Resident Judge for any or all breeds/classes approved, or previously approved without assigning a reason.

5. Regulations - Affiliate responsibilities

- 5.1. The Affiliate or Organisation conducting the Event must not advertise or otherwise announce the name of any judge who is not a resident of Australia until they have been formally approved by the ANKC Ltd and the affiliate officially advised of approval.
- 5.2. The sponsoring affiliate (i.e., the club/s contracting the judge) will:
 - 5.2.1. Ensure all application fees are paid at the time of application.

- 5.2.2. If the judge is being subcontracted to other affiliates – include details of all assignments in the application – include a copy of the sub-contract form(s) for the additional assignments.

5.3. On approval:

- 5.3.1. Ensure the judge is provided with the link to the current ANKC Ltd breed standards/Rules/Regulation for the relevant discipline. For Conformation judges this is to include The ANKC Ltd Glossary of Canine Terms and ANKC Ltd Judging Dogs in Australia - Guidelines for Non Resident Judges. (printed copies available from each ANKC Ltd Member Body at no charge.)
- 5.3.2. For disciplines that require additional information e.g., agility course, advise the judge on the date that these are required to be submitted to the affiliate for submission to the ANKC for the attention of the relevant delegate – additional time should be allowed for in case amendments are required.
- 5.3.3. Provide to the judge all information regarding judging in Australia including classes, judging procedure being used, awards to be made, equipment.
- 5.3.4. Correspond with the judge to keep him informed of arrangements for his visit to Australia, including correct information on visa application and travel insurance.
- 5.3.5. At the events, provide experienced stewards to assist the judge.
- 5.3.6. Visa applications
 - 5.3.6.1. The judge needs to include the affiliate's secretary as a contact on the visa application to enable the secretary to make enquiries if there is a delay with the issue of a visa.

REGULATIONS FOR HANDLING COMPLAINTS AGAINST NON RESIDENT JUDGES (Adopted 05/00)

1. Official Complaint

- 1.1. Where an ANKC Ltd Member Body or its affiliate Club receives an official complaint, being a complaint in writing from a Member accompanied by the fee payable (if any) and with a request that it be dealt with by the Member Body in accordance with its Rules and Regulations with regard to the conduct of a Non-Resident Judge, the ANKC Ltd Member Body shall deal with such complaints in accordance with the requirements of the Rules and Regulations of such ANKC Ltd Member Body.
- 1.2. The ANKC Ltd Member Body must advise the ANKC Ltd Administrator of the outcome and full details of all matters affecting a Non-Resident Judge dealt with in accordance with their Rules and Regulations.
- 1.3. The ANKC Ltd Administrator will forward all material received from the ANKC Ltd Member Body regarding such official complaint concerning the conduct of a Non Resident Judge to the members of the ANKC Ltd Non Resident Judges Approval Board to prepare an agreed recommendation for resolution at the next available ANKC Ltd Board meeting.
- 1.4. The ANKC Ltd Non Resident Judges Approval Board shall take any such matters into account when considering future applications for a Non Resident Judge to officiate in Australia.

2. Grievances Received in Writing

- 2.1. Where an ANKC Ltd Member Body receives written notification of a grievance with regard to the conduct of a Non Resident Judge, not being an official complaint to be dealt with under Regulation 1 hereof, which grievance alleges unacceptable behaviour by a Non Resident Judge, written notification of such grievance must be immediately forwarded to the ANKC Ltd Administrator for resolution.

- 2.2. The ANKC Ltd Administrator upon receipt of such grievance shall forward all material received regarding the grievance to the members of the Non Resident Judges Approval Board to prepare an agreed recommendation for resolution at the next available ANKC Ltd Board meeting. To assist the Non Resident Judges Approval Board, the ANKC Ltd Administrator may seek an explanation and/or clarification regarding the grievance from the Non-Resident Judge.
- 2.3. The ANKC Ltd Non Resident Judges Approval Board shall take any such grievance matters into account, including any response from the Non-Resident Judge, when considering future applications for a Non-Resident Judge to officiate in Australia.
- 2.4. For the purposes of this Regulation, a grievance means:
- (i) a complaint in writing not accompanied by the fee (if any) payable to the ANKC Ltd Member Body to have such complaint dealt with in accordance with its Rules and Regulations; or
 - (ii) a complaint made by a Member of the ANKC Ltd Member Body in which such Member requests that it not be dealt with as an official complaint under Regulation 1; or
 - (iii) a complaint where the ANKC Ltd Member Body determines that it should not be dealt with as an official complaint under Regulation 1 herein.

**AUSTRALIAN NATIONAL KENNEL COUNCIL LTD
NON RESIDENT JUDGES APPROVAL AND APPEAL BOARDS**

PROCEDURE:

Note: The ANKC Ltd Administrator is not to correspond directly with either the Affiliate contracting the Judge or the Non Resident Judge

1. All applications to judge in Australia by Non Resident Judges (excluding New Zealand Resident judges), are to be sent to the State/Territory ANKC Ltd Member Body for dispatch to the ANKC Ltd Administrator for assessment, in accordance with the Regulations.

2. Approval Board

The Non Resident Judges Approval Board of three persons is elected by the ANKC Ltd for a term of one year.

The purpose of this Board is to review applications considered as “borderline” by the ANKC Ltd Administrator, and to consider appeals lodged against a decision made by the ANKC Ltd Administrator. This panel will not meet but will be sent details of the Judge concerned and will independently vote on their eligibility. Majority vote is necessary for acceptance. (10/02)

3. Appeal Board

The Non Resident Judges Appeal Board consists of the ANKC Ltd President (the convenor) and the Presidents from two States other than the one where the host club and those members of the Non Resident Judges Approval Board are located. The three persons must be from different States or Territories.

The purpose of this Board is to consider appeals lodged against a decision made by the Non Resident Judges Approval Board. This panel will not meet, but will be sent all details of the appeal; a copy all previous supplied information and a copy of each member of the Non Resident Judges Board recommendations, and will independently vote on the eligibility. Majority vote is necessary for acceptance. **(adopted 10/02)**.

4. Regulations for eligibility have been adopted by the ANKC Ltd and all ANKC Ltd Member Bodies.
5. The Affiliate of the ANKC Ltd Member Body contracting the Non Resident Judge in Australia is required to provide to their ANKC Ltd Member Body the following:
 - (i) ANKC Ltd Judging Application for “Persons not a Resident of Australia”.
 - (ii) Relevant completed Addendum A and/or B.
 - (iii) Payment of the relevant fee, payable to the ANKC Ltd to cover administration The fee is to be paid by the Affiliate contracting the Judge and requesting the approval. **(10/99)**

Application Fee seeking approval for a Non Resident Judge

- Applications received by ANKC Ltd Member Body nine (9) months prior to the first event: \$50.00 incl. GST **(effective 01/01/03) (10/02)**
 - Applications received by ANKC Ltd Member Body less than nine (9) months prior to the first event:
\$100.00 incl. GST **(effective 01/01/03) (10/02)**
- (iv) The name, State/Territory and date of each event the Non Resident Judge is likely to be contracted or sub-contracted to judge in Australia during their proposed stay in Australia.
 - (v) A list of breeds and / or discipline classes the Non Resident Judge is proposed to judge at each of the above events.
 - (vi) A statement of authorisation of judging qualifications from the Non Resident judge's controlling body (if not provided, ANKC Ltd will obtain, at extra charge). The Controlling Body must be one that is recognised by ANKC Ltd. **(Amended 10/13 – 5.6.4)**

When the ANKC Ltd Member Body has all the above information, and only then, they will forward the information to the ANKC Ltd Administrator for approval or otherwise.

6. After processing the application, using the ANKC Ltd Regulations, the ANKC Ltd Administrator will advise the ANKC Ltd Member Body of the breeds / discipline classes for each event the Non Resident Judge has been approved, who in turn will advise the Affiliate.

A copy of this approval is required to be sent to each ANKC Ltd Member Body by the Affiliate for each event where the Non Resident Judge is judging, when submitting their event schedule for approval.

7. The contracting Affiliate is to send the following documents to the Non Resident Judge when all Judges' Contract/s have been confirmed. These can be provided in hard copy or by providing links to the current documents on the ANKC website:

- (i) The Standards for all the breeds the Non Resident Judge has been approved to judge in Australia.
- (ii) The ANKC Ltd Glossary of Canine Terms.
- (iii) ANKC Ltd Judging Dogs in Australia - Guidelines for Non Resident Judges.**
** available from each ANKC Ltd Member Body at no charge.
- (iv) Non-conformation judges to be provided with Rules and Regulations which relate to the discipline they are judging. For disciplines that require additional information e.g. agility course, advise the judge on the date that these are required to be submitted to the affiliate for submission to the ANKC for the attention of the relevant delegate – additional time should be allowed for in case amendments are required
- (v) Provide to the judge all information regarding judging in Australia including classes, judging procedure being used, awards to be made, equipment to be used.

8. The ANKC Ltd Administrator will establish a register of Non Resident Judges and record all appointments in the register. Such register shall also appear on the ANKC Ltd's Web Site.

The register is to contain the following:

- (i) The name and country of residence of the Non Resident Judge
- (ii) The Breed/s and or discipline classes approved
- (iii) Details of the events approved:
 - the name of each event
 - the date of each event
- (iv) Any reports concerning the Judge, either favourable or unfavourable.

9. Affiliates may appeal either a decision made by the ANKC Ltd Administrator or a decision made by the Non Resident Judges Approval Board. All appeals are to be lodged via the Affiliate's ANKC Ltd Member Body, who will refer the appeal to the ANKC Ltd Administrator, along with the Appeal fee. **(Adopted 10/02)**

- (i) Each time an Affiliate lodges an appeal they will be required to pay a fee as determined by the ANKC Ltd. The fee payable to the ANKC Ltd, to cover Administration costs.

The Appeal Fee to \$50.00 incl. GST per Judge (effective 01/01/03) (05/05)

- (ii) The ANKC Ltd Administrator will automatically refer an appeal against a decision of the ANKC Ltd Administrator to the Non Resident Judges Approval Board for processing.
- (iii) The ANKC Ltd Administrator will automatically refer an appeal against a decision of Non Resident Judges Approval Board to the Non Resident Judges Appeal Board, for processing.
- (iv) An appeal shall include new information that was not included in the initial application.
- (v) Appeals are not to be referred to an ANKC Ltd Board meeting.
- (vi) When processing an appeal, either by the Non Resident Judges Approval Board or the Non Resident Judges Appeal Board, they must only consider the appeal against ANKC Ltd Regulations Part 9.
