

# INFORMATION REGARDING REGISTRATION

The attached form may be submitted as soon as the Breeder has received confirmation from Dogs NSW of the prefix registered in his/her name.

The following points should be noted:

1 **Membership Number** - This number appears on the letter of prefix confirmation.

2 **Owner of Sire** - Membership Number - Breeders are advised of Dogs NSW regulation which requires the owner of a sire used at stud to hold membership of Dogs NSW before any application for registration of progeny can be accepted. The interstate owner of such sire is not, however, required to hold membership.

3 **Common Names** - a number of important rules should be remembered in selecting names for your dogs:

A name being the same as any breeders prefix registered with Dogs NSW will not be accepted. A dog's name may not exceed 30 characters including spaces between words and the breeders prefix.

- The words "imp" "champ" "of" "ie" "vom" "von" "le" or any numbers (eg: I, IV) , cannot be used.

Breeders are advised to suggest an alternative common name for each dog; where a common name is unacceptable and no alternative name is given a name will be selected and registered for you.

4 **Sex** - The letter 'M' or 'F' alone is sufficient to indicate the sex of the puppy to be registered.

5 Any application received more than 18 months after the date of whelping cannot **in any circumstances** be accepted.

6 **Fees** - Please ensure that the correct fee is enclosed with your application.

## GENERAL

When your application for registration has been processed, a Certificate of Registration will be forwarded to you in respect of each pup registered.

Where a pup is sold, the reverse side of the Certificate of Registration must be completed by the breeder and new owner(s) then lodged with Dogs NSW , and provided that the details therein are accepted by Dogs NSW in every respect, and the prescribed fee accompanies the application, transfer of ownership will be recorded and a new Certificate of Registration will be forwarded to the new owner(s).

### Puppies sold on the Limited Register

In order to protect both our breeders and the new owners a form has been instigated which acknowledges that:

- The breeder has explained the restrictions of the Limited Register
- The new puppy owner signs to acknowledge that the breeder has explained the restrictions of the Limited Register

All parties must sign this form and the completed form **MUST** accompany the Certificate of Registration when it is lodged in the office to record the transfer of ownership.
