CLASSES: No Classes other than the following shall be provided OR omitted without the special permission of Dogs NSW.

DEFINITIONS OF ELIGIBILITY:

The following should be read in conjunction with the ANKC RULES for the relevant discipline

COMMUNITY COMPANION	For dogs, six months of age or over, and of either sex which are not eligible for the title of Community Companion Dog (C.C.D.). Under no circumstances except where an application for a C.C.D. Title has been rejected on a technicality, shall a dog, which has gained a qualifying score in a Novice Class, be eligible to compete in the Community Companion Dog Class. A dog is not permitted to compete in the Community Companion Dog Class and a Novice Class at the same trial
NOVICE	For dogs which are not eligible for C.D.
OPEN	For dogs that have attained the C.D.Title.
UTILITY	For dogs that have attained the Title C.D.X.
UTILITY DOG EXCELLENT	For dogs that have attained the Title 'Utility Dog' (U.D.)
RATG NOVICE	For Gundogs that have not previously received three passes in Novice Retrieving Ability Tests for Gundogs under at least two Judges
RATG OPEN	For Gundogs that have received three passes in Novice Retrieving Ability Test for Gundogs.
TRACKING DOG	For that have not attained T.D.Title.
TRACKING DOG EXCELLENT	For dogs that have attained T.D.Title.
TRACKING CHAMPION	For dogs that have attained T.D.X. Title
TRACK & SEARCH DOG	For dogs that have attained Tracking Champion Title
TRACK & SEARCH DOG EXCELLENT	For dogs that have attained Track & Search Dog Title
TRACK & SEARCH DOG CHAMPION	For dogs that have attained Track & Search Dog Excellent Title
TRACK & SEARCH GRAND CHAMPION	For dogs that have attained Track & Search Dog Champion Title
ENDURANCE TEST	For dogs aged between 2 years and under 8 years on the day of the Test
EARTHDOG TEST	REFER TO ANKC RULES

NOTES:

- (a) (i) An Exhibit which has gained sufficient awards to qualify for the title of C.D., C.D.X., or U.D. shall NOT be eligible to compete in a higher class at an Obedience Trial until such time as the owner/s have lodged an application for recognition of the title with the Member Body in the State or Territory in which the registered owner/s reside.
- (ii) An Exhibit which has gained sufficient awards to qualify for the title of RN, RA, or RE shall NOT be eligible to compete in a higher class at a Rally Trial until such time as the owner/s have lodged an application for recognition of the title with the Member Body in the State or Territory in which the registered owner/s reside.
- (iii) Qualifications up to, and including, the date of closing of entry shall count as eligibility to compete in any Class.
- (b) An Exhibit, which has gained sufficient awards to qualify for a Tracking Title or a Track and Search Dog Title shall NOT be eligible to compete for a higher title at a Tracking or Track and Search Dog Trial until such time as the owner/s have lodged an application for recognition of the title with Dogs NSW or Canine Control in the State or Territory in which the registered owner/s reside.

RULINGS:

- 1/ Where Teams are competing at an Official Trial, only qualifying scores will be counted.
- 2/ Special or Perpetual trophies are considered a domestic matter for the individual club subject to the above rulings
- 3/ Bitches in oestrus may not be shown or be in the precincts of the Trial ground.

IMPORTANT:

- (a) Regulations in respect of competitions for performance titles must be observed at all times
- (b) Qualifying Certificates must be fully completed and signature of the judge must appear thereon
