APPLICATION FOR OVERSEAS JUDGE

If an Affiliate invites an Overseas Judge to officiate at a Test/Trial it is now incumbent upon the Affiliate to request the Judge to complete the "Official" Application form approved by the Australian National Kennel Council (available from Dogs NSW Office) and that the judge obtain from the Controlling Body with whom he/she is approved, or licensed to judge, a letter stating their judging qualifications.

The Affiliate shall also request the Judge to forward the completed application form together with the letter to the Affiliate concerned. It in turn will forward the information to Dogs NSW.

Sufficient time is essential to allow information to be obtained by the ANKC to confirm the information supplied and it is therefore essential that applications for approval be lodged nine months before the fixture together with the appropriate fee **made payable to the ANKC** (fee on request).

Should an exhibitor require a receipt for entry fees, he/she is requested to include an addressed envelope with a request in writing to the Secretary of the Affiliate.

I hereby declare that all the Dogs NSW Rules & Regulations will be strictly observed, the Judge's contracts are in order and the abovementioned information will be included in the Printed Schedule for this Club's Test or Trial.
