2. Interstate residents are required to hold a current membership with the Member Body in the State that they reside to be eligible to enter, exhibit or handle at any Shows or Trials conducted outside their State of residence.
3. Renewal of membership will be due 1 July each year. A renewal notice and reminder notice will be sent via email.
4. Membership cards are issued digitally and can be accessed via the DOGS NSW mobile app.
