Place a cross **X** in the square opposite the names of the candidates for whom you wish to vote. If you vote for more than four (4) your vote may be invalid.

2. After marking the ballot paper, fold it and place in a standard sized envelope and mark the envelope on the front 'Ballot Paper.'

3. Place the envelope marked 'Ballot Paper' in another envelope, seal and PRINT YOUR NAME, ADDRESS, MEMBERSHIP NUMBER AND SIGN YOUR NAME ON THE REAR OF THE ENVELOPE CONTAINING THE BALLOT PAPER. If the particulars required are not complete, the envelope may be rejected and the vote not counted.

DO NOT ENCLOSE ANYTHING OTHER THAN THE 'BALLOT PAPER ONLY' ENVELOPE IN THIS ENVELOPE.
