

Privacy policy

Royal NSW Canine Council Limited[®] trading as DOGS NSW[®] (referred to as "DOGS NSW", "we" and "us") recognise that the privacy of your personal information is important to you and are committed to protecting the privacy of any personal information we collect from you. Unless you give us your consent to do otherwise, we will only collect, use and disclose your personal information in accordance with this Privacy Policy.

DOGS NSW[®] abides by the Australian Privacy Principles ("APPs") under the Privacy Act 1988 (Cth) ("Privacy Act"). This Privacy Policy outlines how we will handle and manage your personal information. You can obtain information about the APPs and your privacy rights at the website of the Office of the Australian Information Commissioner at www.oaic.gov.au/privacy-portal/.

Observing and protecting the confidentiality of your information is an essential aspect of the conduct of our business. We generally disclose such information only in accordance with our Privacy Policy.

What information do we collect?

We primarily collect personal information that is necessary for us to promote the welfare of purebred dogs and responsible breeding. Personal information is any information that can be used to identify you and may include:

- your name, address, occupation and contact details (address, telephone numbers, date of birth and email address);
- breed of dogs owned and information regarding canine activities you currently participate in;
- information about the services or goods you have ordered from us;
- other personal information you may disclose to us when you contact us or request a service or good from us or which is otherwise contained in communications between you and us; and
- credit card information.
- where you are applying for employment with us, relevant employment history. We may ask you for other information, for example, qualifications.

How do we collect and hold your personal information?

We usually collect personal information in the following ways:

- Directly from you, either in person, in documents, by email or via the DOGS NSW website

We hold personal information in hard copy and electronic files.

If your personal information is no longer needed, DOGS NSW[®] will take reasonable steps to destroy or permanently de-identify it.

Collection of information from the DOGS NSW[®] website

When using the DOGS NSW[®] website you may voluntarily disclose personal information to us. Our server may automatically record details such as your internet address, domain name if applicable, and the date and time of your visit to our website. This information is used for internal purposes only, including statistical purposes.

We will not try to identify users or their browsing activities except as necessary to investigate or report any suspected unlawful activity, as required or authorised by law or as reasonably necessary for the activity of an enforcement body.

The DOGS NSW[®] website uses cookies, which may collect personal information. Cookies are pieces of data stored on your browser that record information on your use of the DOGS NSW[®] website, such as details of your server and your browsing activity, and send the information to the server. We use these cookies to monitor usage of the DOGS NSW website only. You may be able to change the settings of your browser so that cookies are not accepted generally or that you are provided with options to accept or reject them as they are sent to your browser. You might not be able to use the full functionality of the DOGS NSW[®] website by refusing the use of cookies.

Why do we collect personal information and what are the consequences of not providing us with the information requested?

Generally, we collect personal information about you for the provision of our goods and services, to meet our obligations to you as well as to enable us to contact you regarding your dealings with us. We also collect personal information so you can seek employment with us

or communicate with us in writing, by e-mail, telephone or via the DOGS NSW[®] website. Our ability to meet our obligations to you, or to process any application may be adversely affected if you do not give us the requested personal information, or if the information you give us is incomplete or inaccurate.

How do we use your personal information?

We use personal information primarily to provide our services to you in the ordinary course of conducting our business. We may also use personal information to:

administer, process and assess applications from members, affiliates and members of the public;

- for new membership
- membership renewals
- transfer of dogs/puppies
- provide and administer all aspects of breeder services;
- administer and/or conduct events for all Australian National Kennel Council Limited approved disciplines;
- distribution of our monthly magazine;
- publication of Judges' contact details on the national website;
- handle complaints about members or former members;
- improve our services with you; and
- notify you of opportunities that we think you may be interested in.

If we intend to use any of your personal information for direct marketing, such as by adding you to a marketing database, and you have not already consented to this use, we will notify you and will provide you with an opportunity to opt out.

If you no longer wish to receive our email alerts you may opt out at any time by replying to the email using the unsubscribe facility.

To whom do we disclose personal information?

We will only disclose personal information for the purpose for which it was collected or in the following circumstances:

- to other goods and service providers who assist us in servicing you;
- with your consent, to other individuals enquiring about your dog breeding activities;

- where required or authorised by law or otherwise as permitted under the Privacy Act; and
- where you consent or have authorised a third party to consent to the disclosure.
- to a member or former member who is subject of a complaint which is dealt with by way of an Inquiry Hearing under the Regulations

Cross-border disclosure of personal information

DOGS NSW[®] is unlikely to disclose your personal information to overseas recipients. Should DOGS NSW[®] be required to disclose your personal information to overseas recipients, we will do so in accordance with this Privacy Policy and the Privacy Act.

How secure and accurate is your personal information?

We will take reasonable steps to ensure that all personal information we hold is:

- accurate, complete, up-to-date, relevant and not misleading;
- stored in a secure environment; and
- protected from misuse, interference and loss as well as unauthorised access, modification or disclosure.

If any of your details change, please let us know as soon as possible by using the contact details below so we can maintain the accuracy of your personal information.

How can you access and correct your personal information?

We seek to ensure that all personal information collected is accurate and complete. You have a right to access personal information we hold about you either by contacting us at privacy@dogsnsw.org.au or by accessing your membership record online via the DOGS NSW[®] website.

We will comply with any request to access your personal information that you send us by email at privacy@dogsnsw.org.au except where the Privacy Act or the APPs allow us to refuse to do so. There is no fee for making a request to access your personal information but we may charge a fee for giving you access to your personal information in a mutually agreed format, usually by sighting the accessible information held on file. You also have the right to ask us to correct information about you that is inaccurate, incomplete, out-of-date, irrelevant or misleading. If we refuse to correct your personal information as requested, we must:

- notify you in writing of the reasons for the refusal (unless it would be unreasonable to do so) and how to complain of the refusal; and
- upon request from you that we associate a statement that the information is inaccurate, incomplete, out-of-date, irrelevant or misleading, take such steps as are reasonable in the circumstances to associate such a statement so that it will be apparent to users of the information.
