Treasurers Report – Western Region of Dogs NSW For AGM, year ending 30/06/2023

This was an unusual year for the Western Region.

We normally run one weekend of three Championship Dogs shows annually, but because of a quirk in scheduling, this financial year we ran two weekends, one in conjunction with the Condobolin circuit in August 2022, and the other in March 2023 in conjunction with Lithgow Kennel Club.

I could not attend the first [August 22] as I was in hospital. Secretary Gail was unwell, so Virginia took on the task of running our shows as well as the others on the Condo circuit. Since all meetings have been by Zoom, it was not till March 23 that we were able to reconcile the show financials for those shows. Virginia did an exceptional job keeping track of it all.

We made a modest profit on the shows at Condobolin. However, we could not achieve the same results for the Lithgow based shows, despite most exhibitors rating them successful and enjoyable.

Attached are three spreadsheets.

- $1^{st}$ . The Final Statement from Dogs NSW accounts department. This shows a balance of \$4239.81 at  $30^{th}$  June 2023.
- 2<sup>nd</sup>. Budget Actual Result of the Shows at Lithgow, at which we made a loss of \$1711.83. The main factors were high expenditure on the interstate judges, especially their travel expenses and car hire. We need to review whether a full interstate panel is worth the trouble.
- 3<sup>rd</sup>. A spreadsheet of the cash float taken out by myself and then reimbursed, showing actual cash expenditure, in particular the Judges cash expenses.

Our cash holdings reduced over the financial year because of these factors, so we need to be careful of future expenses at shows.
