I hereby apply to enrol in the Conformation Judges Education Program (**AS AN ASPIRING JUDGE**) on the terms and conditions set out in DOGS NSW REGULATIONS PART III CONFORMATION JUDGES EDUCATION PROGRAM (CJEP), published on DOGS NSW website www.dogsnsw.org.au.

I also acknowledge and accept that pursuant to the abovenamed Regulations any decision of the DOGS NSW Board of Directors on any matter arising or relating to the Program or the Regulations shall be final and binding.

I declare that I am physically fit and capable of judging in accordance with the Regulations, and if required I am prepared to undergo a medical fitness test and/or vision test at the discretion of DOGS NSW. I further accept Dogs NSW may at its absolute discretion refuse to grant any renewal of licence and may cancel or suspend for any period or vary in any way any licence already granted or to be granted. Or may grant, in part, only an application for renewal of licence.

FURTHER, I acknowledge the conditions under which I am being permitted to enter into the 2026 CJEP (ONLY) as an Aspiring Judges, which are as follows:-

- Enrol in the Aspirant Judges Program which opens in August 2026 and concludes in October 2026 – failure to enrol will automatically exclude them from continuing further in the CJEP 2026/2027;
- Aspirants to acknowledge in writing that they:
 - accept the condition as noted above, and;
 - acknowledge that they **must** successfully complete the Aspirant Judges Program by passing the Examination in October 2026 in order for their theory results in Sub-Groups 1 through to 3 and to be counted towards the overall theory component **and** before they can enrol in Sub-Group 4 in 2027 and (if they successfully obtain the required overall theory pass mark) be eligible to sit the Practical Examination for their Group to be held in September 2027; *and*
 - acknowledge that this is a “one-off offer” to Aspirant Judges for the CJEP 2026/2027 program only.
